




Figure 1 | Share of employment in central/federal public administration in the total population




Figure 2 | Share of employment in central/federal public administration in the working population




Figure 3 | Share of employment in central/federal public administration in the employed population




Figure 4 | Total number of central/federal public administration staff by gender




Figure 5 | Civil servants vs Contractual staff




Figure 6 | Staff average age (years)





Figure 7 | Top 5 Sectoral areas with highest staff





Figure 9 | National Administrations senior managers by gender (2020)

- 3. It has to be noted that Belgium has multiple layers regarding the public administration (federal, regions and communities). If we count all their staff together, it comes up to 843.000 persons in total (including teachers e.g.), which results in 17,55% of the working population.
- 4. Bulgaria working population: from 16 years old up to 61 and a half for men and 64 and 3 months for women 4 139 056.
- 5. For Cyprus, the term includes the civil service, educational service, armed forces of the Republic, security forces of the Republic and judiciary service. Working population: aged 15+ = 448.181. - 2. Bulgaria The actual number of real employed staff is 131,812, as there are legal hypotheses under which more than one employee can be appointed to the same position.
- 3. Cyprus Permanent employees: 31.674, temporary (with indefinite contract) employees: 6.526, contractual employees: 3.791 and hourly-paid staff: 8.471.
- 4. Switzerland These figures do not include military personnel and the Swiss Border Guard.
- 5. Poland Data provided relate to the civil service corps in Poland exclusively. In general in Poland we have rather narrow concept of the civil service. It is composed of employees of: ministries, central offices (agencies), voivodeship offices (regional government offices), tax and revenue administration, and other persons. FTEs 118 885
